CITY ON THE HILL MUSIC FESTIVAL - Important Information Regarding Food Vendors

Terms

Vending space is located within Bayfront Festival Park with a 7 ton axel loading limit. You are responsible to provide your vending tent or booth including all supplies. Parking is nearby. Each space gets up to four (4) vendor passes allowing entry in and out of the park. Additional passes can be purchased for \$20 each. The event begins at 2PM on Friday - you must be set up and ready to go by 12PM Noon. You are not allowed to tear-down or vacate the space earlier than 10PM on any night. You are NOT allowed to sell any beverages at your booth - this includes soda, water, tea, lemonade, coffee, energy drinks, etc.

Permit

You are required by the health department to have a Minnesota State Food Handlers License, a USDA Food Handlers License, or a State of Minnesota Special Event Food Service License. License applications and fees must be submitted to the appropriate regulatory agency at least 14 days prior to the event. Plan accordingly! You may contact: Minnesota Department of Health at: 651-201-4500 extension 4 to request an application. You will be referred to an inspector.

Electrical Needs

It is your responsibility to insure that your portable electrical systems (cords, wires) are in compliance with the State of MN Electrical Inspections Department. If your cord does not comply with requirements, you will not be allowed to offer your food items.

Turn right to reach West Commercial Street. Take a left on West Commercial Street and a left to enter the park vendor entrance.
